As to apportionment of rents and other periodical payments in the nature of income, it is enacted by the Apportionment Act 1870, (33 and 34 Vict C-35) 8-2 that from and after the death, passing of the Act all rents, annuities, dividends, and other periodical payments in the nature of income shall, like interest on money lent, be considered as accruing from day to day, and shall be apportionable in respect of time accordingly (and see the interpretation of the words rents, annuities, and dividends, in section 5); but the Act is not to apply where there is an express stipulation against apportionment (s. 7). This comprehensive enactment is much more general in its application than the old Apportionment Act of 4 and 5 Wm. 4, c. 22, and avoids many of the questions which have arisen under that Act (as to which see Shelford's Real Property Statutes, 8th ed. , by Carson, pp. 543, et seq.).
